NARRATIVE <p>On Monday, 04/22/19, I met with staff in the city of Stockbridge City Hall in regards to concerns regarding a citizen (Randazzo) residing within the city limits of Stockbridge. The subject has voiced concerns to representatives of the city of Stockbridge over several issues during a course of several months.</p> <p>The issues ranged from the following:</p> <ul style="list-style-type: none"> • Frustration over a pine tree damaging a family home and requesting help from the city of Stockbridge. • Frustrations over open records request and displeasure in not receiving the request in an expedient time frame. • Displeasure over the proposed construction of an amphitheater near the Randazzo home in which the subjects sends an email stating "I may as well bulldoze my fucking home. Thanks, assholes." <p>I was informed there were no direct threats to anyone, but the City of Stockbridge staff wanted the incidents documented because of concern due to the emails received. Printouts of several emails were attached to this report and I was informed there may be more emails provided at a later time to also document the contact the subject has with the representatives of Stockbridge.</p>

To Mr. Knighton, Mayor Neal, and members of the council.

Hello. I'm Sunny Randazzo.

My home was hit by a pine on 9/11/2017. The damage was extensive and we're expecting to rebuild 2/3. Although the insurance is still crunching numbers we have coverage for non-use/rental. When construction begins at 111 Bryant we will need to vacate for 2-4 months. The City holds three vacant homes on Lee St. Less than 1/4 mile from my home.

I propose we attempt to keep the money in the city by allowing my family of 3 to rent one of the properties. It would be cheaper for my insurance company. It would allow the city to recoup funds for the maintenance you perform on the three yards. It would allow me to keep a close eye on construction and ensure I can not only rebuild my home properly, but also raise the property values of others here in the neighborhood.

Hello,

My name is Michael and I represent a new media outlet in Henry County.

I am sending this seeking updated comment from Mr. Knighton on a story we're writing concerning false accusations made in the ELERC press release concerning persons arrested over threats.

It has recently come to light through court records (attached) that the terroristic threat charge is uncorroborated. My research shows the detective has 3 unfounded terroristic threat charges in the last 18 months. The detective lives in the country club. The HCPD and HCSO have confirmed no other persons arrested in connection with the alleged threat. Mr. Randazzo states, "I haven't threatened or harassed anyone." The warrant, incident report, and Randazzos phone record seem to back up his statement.

Do you have any comments concerning the accuracy of the Detective Fisher or the press release that lead to the unfounded arrest?

You were previously quoted on 11 Alive...

"The city of Stockbridge learned Sunday of the reported incident involving a threat by a private citizen to a member of the committee," said Randy Knighton, city manager. "The reported incident is unfortunate and bothersome. We will continue to advocate civility in all community discussions. Stockbridge continues to be a community of hard-working Americans. We encourage community members to stay engaged at all times."

Would you care to comment again, now that the charge is proven unfounded?

We welcome any other thoughts you have in this matter, or any matter. We're aiming for an April 31 deadline.

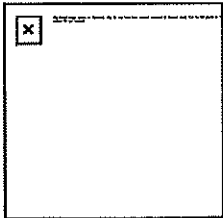

NARRATIVE

On 10/24/19 at approximately 0940 hours I was advised by Sgt Huffman of an incident that occurred at Stockbridge City Hall, 4640 North Henry Blvd in Stockbridge (Henry CO) GA in regards to a subject who has had a history of harassing the employees through social media, emails, phone calls, and in person encounters.

I made contact with the front office receptionist, Kerri Stewart, who stated that on 10/16/19 Coren Michael Randazzo (OLN 042581231) came to Stockbridge City Hall to drop off documents to several city employees. Ms. Stewart stated that Mr. Randazzo asked her to time stamp the documents before he scanned them with a personal scanner he had in his pocket. Ms. Stewart stated that Officer Subczak was on duty that day at City Hall as security and that appeared to Ms. Stewart to make Mr. Randazzo nervous as he was 'shaking uncontrollably' while he scanned his documents. Ms. Stewart stated that "a few days later" she was informed by the City of Stockbridge's Public information Officer that Mr. Randazzo posted a video on YouTube of the encounter with her on 10/16/19 and calling Ms. Stewart the "Stockbridge Gate Keeper". Ms. Stewart stated that Mr. Randazzo went on to state in that video that she could not do her job and that he then emailed the City Human Resources Department with screenshots of film he had taken during their encounter of Ms. Stewart's computer and the contents displayed on it.

Ms. Stewart continued on to state that she fears any encounter with Mr. Randazzo because of previous encounters with him. Ms. Stewart was specific in stating that on August 26 , 2019 Mr. Randazzo called City Hall and began to state "y'all are going to pay" and "watch and see". Mr. Stewart stated that on that date Officer Richardson then took over the phone call from Ms. Stewart. Ms. Stewart went on to state that Mr. Randazzo often calls and emails her and several other employees. Ms. Stewart stated that Mr. Randazzo has created a sense of fear in her as she is unsure of what he may do to herself or other in City Hall.

I then spoke with Randi Rainey who works in the records department for the City of Stockbridge who stated that Mr. Randazzo had to be advised to no longer send her emails after he became upset that she would not provide records that did not exist. Ms. Rainey stated that Mr. Randazzo wanted records of when the ground breaking ceremony for the Stockbridge Amphitheater would be. That date was spanning from August 22, 2019 until August 26, 2019 where Mr. Randazzo requested the records and then after being informed the record did not exist he emailed Ms. Rainey again stating he called and was informed by "Henry Police" that his phone calls were "harassing"

and that he has "been banned from calling the city." It was upon receipt of this email that Vanessa Holiday, the City Clerk advised Mr. Randazzo through email not to contact Ms. Rainey any further.

I tried to make contact with Ms. Holiday but she was not in the office to make a statement or provide any further documentation that may have been available.

I then contacted Randy Knighton, City Manager, who stated that Mr. Randazzo has made several comments via social commenting with things like "fuck you" Mr. Knight and stated the same to Mayor Ford. In one tweet Mr. Randazzo "I told you not to run the traffic down Bryant anymore.....You people are fucking disrespectful". Mr. Knighton advised there are several more tweets like those already provided in Mr. Randazzo's twitter feed. Mr. Knighton advised he has received other communications from Mr. Randazzo in the past but believes those have all been submitted under case number 19-007399. Mr. Knighton also advised that Mr. Randazzo has started coming to City Council meetings causing a sense of fear to City employees because of his social media posts and communications. Mr. Randazzo's last attended meeting was 10/14/19.

I then made contact with Mayor Anthony Ford who stated he would look through his email to see if he received direct emails from Mr. Randazzo as he could not remember all of the communication methods Mr. Randazzo has used. Mayor Ford advised he would give Henry County Police any communications he discovers that was submitted by Mr. Randazzo to him.

I was given the following social media account names that Mr. Randazzo claims to be his own:

Twitter: StockbridgeAmphitweeter

Several of the County Employees have feared coming forward with their information due to fear of retaliation from Mr. Randazzo. They have stated they are fearful of him gathering their personal information and sending more communications to their homes, personal phones, or possibly showing up at their addresses.

They have also expressed fear in the ground breaking ceremony of the Stockbridge Amphitheater as Mr. Randazzo has gone to great lengths at showing a strong arm towards City employees in regards to the Amphitheater. Mr. Randazzo has purchased

I am Mr. Coren Randazzo, a property owner on Bryant St. here in Stockbridge. I've been a resident of Stockbridge & surrounding area for 30 years. I've owned my home, outright, for 2 years now.

I was diagnosed 10+ years ago with Schizoaffective disorder. As a person with a disability under the Americans with Disabilities Act (ADA), I am requesting reasonable accommodation to allow me to enjoy the use of this home I've worked so hard for. The worst effects of my disability are brought on by stress. Persistent loud noises can cause a great deal of stress due to a condition known as Hyperacusis. Further leading to symptoms resembling Misophonia.

Please let me know if you need medical documentation of my disability and need for accommodation. My suggestion is simply to follow existing laws. No engine braking, no thru traffic, and stop exempting the City of Stockbridge functions from the noise ordinances. It's well known that speed humps cause far less noise pollution than speed bumps. Please consider converting the speed bumps on Bryant street into humps. As the amphitheater is being built please contain the construction and truck traffic to Hwy. 42 & Lee St. Please detail to me the size and type of speaker array for the city hall amphitheater. Please outline the noise control plan for the City Hall Amphitheater project including any noise abatement wall or other similar structure. If I can't be made privy to the details of the speaker setup. Please consider no flying arrays, or any speakers placed above the noise barrier or abatement wall. Use cardioid speaker arrangements and practical beam steering techniques to lessen the long range low frequency propagation. Put very simply, please help me keep my home livable by using existing laws, common courtesy, and proven engineering techniques.
